- Uni.Fund, the Uni.Fund team, us, we: All the terms refer to the Owner of the Site, as formerly described. In these Terms of Use the terms "Uni.Fund", "Uni.Fund team" as well as the pronouns "us" and/or "we" may be used interchangeably to denote the Owner of the Site.
- <u>Visitor, Visitors, you:</u> Anyone visiting, accessing or in any way browsing the Site is referred to as
  "Visitor" or "Visitors". All Visitors should be adults, (over 18 years old) and they are continuously
  bound to follow the Terms of Use while accessing, browsing, or otherwise using the Site.

# C. Purpose of the Site, Use and Content

#### a) Purpose

- 1. The Site was created to provide information and updates regarding Uni.Fund, our mission, our portfolio and activities, allow anyone interested contact us, subscribe to our newsletter, and/or apply to become one of the Uni.Fund teams.
- 2. The material on this site is exclusively intended for adults/persons who are at least 18 years old. By browsing or using the Site you are assumed to be an adult. If any minor accesses, visits, browses or otherwise makes use of any provided functionalities/services of the site which could, the Owner and Site's administrator bear no responsibility. (For the collection and process of minors' data through our contact form, application forms and newsletter subscription form please see our Privacy Policy.)

#### b) Use

- 1. The usage of the site is governed by these terms, the Privacy Policy and the Cookies Policy which you are expected to adhere to. (See A.)
